# Services Provided July 2017 through September 2017

#### SUMMARY

- 83 individuals received 100 units of service including I/R, consults and training. From July to September 2016, we'd only provided 16 units of service; 625% growth in service units.
- ♣ ASAGA Board and Volunteers provided 26 volunteer hours
- ASAGA connected with individuals in 11 Alaskan communities and Out of State guardians
- ↓ We had 1302 site visits to our webpage. 217 July, 701 August & 384 September.

#### **Information & Referrals**

ASAGA provided 43 units of information and/or referrals. Contacts ranged from finding necessary paperwork online, where to find educational materials or help finding available trainings. Three were triage questions with ASAGA volunteers.

#### Consultations

ASAGA provided 46 consultations this quarter. Out of the 46, 5 were Triage Consults with ASAGA volunteers; 1 was with our interpreter service and 11 were in-person at the ASAGA office. Topics ranged from petitioning, annual reports, child custody, benefits and moving out of state.

### Training

As summer is a difficult time for people to attend training, ASAGA did not offer any webinars in July and August and the one webinar for September did not have any attendees, however was requested by several after the fact so it will be offered at a later date. We primarily focused on our October conference launching early registration from August 1<sup>st</sup> to September 30<sup>th</sup> at \$75.00, Regular Registration begins 10/1 at \$85. ASAGA did the in-person class at OPA in August and September (July fell on the holiday) with 8 total attendees (four each class).

## **Outreach and Online**

Through IContact, we had soft contact with 922 individuals across the State in 5 different informational emails regarding Conference Registration, General Guardianship News and the Fall Webinars. In addition, ASAGA promoted the Public Forums regarding the new WINGS



program through the Alaska Court System in which ASAGA has a seat in the WINGS Stakeholder Committee. In addition, the ASAGA Administrator facilitated the public forums through a WINGS grant but had the opportunity to do outreach for ASAGA with a total of 78 people in four forums. Through Facebook, we reached over 7356 individuals with posts about our programs and progress but it is likely that some would be duplicated contacts. We have 168 followers. At stated before, we had 1302 visits to our website this quarter; **more than doubling what we'd had the first five months it was live.** 

#### New & Special Projects

#### Video Project

We continue to monitor progress on the video being designed. As of the end of September, the producers felt there should be a rough draft come the end of this year with the hope it will launch the first part of 2018.

#### New ASAGA Programs:

**Jackson Stanley Conference Scholarship –** The board voted to create a conference scholarship which by nomination, will send an Alaskan guardian to the National Guardianship Association in Palm Springs in 2018. To help raise funds, we'll be doing a silent auction at our conference, renting tables for providers to showcase services and holding our 25/25 Campaign. ASAGA is celebrating 25 years in existence and with a donation of Alaska Airline miles will be doing a donation entry system in which each \$25 donation gets you an entry into the giveaway. This will launch in October.

#### Annual Report Reminders:

At the October Conference, ASAGA will launch the Annual Report Reminder voted and approved by the Board. Using IContact, we will create email lists so that family guardians can receive an email reminder that their annual report is due with a follow up phone call a week prior. This will serve as a support program for family guardians.



## **Giving Thanks**

The Alaska State Association for Guardianship and Advocacy is a nonprofit organization and largely made up of volunteers donating their time to assist families and others navigate the guardianship system.
