Detail

ASAGA has received \$48,200.00 for FY20 from the Alaska Mental Health Trust Authority. We thank them for their generous funding and support of having a guardianship assistance program in Alaska. \$38,560.00 was received in October 2019 and the remaining \$9640.00 will be issued after our final report.

ASAGA continues to hold \$6000 from AARP for the second phase of the video project for translation and is working with the Alaska Court System on parameters.

SUMMARY

- ✚ 189 individuals received 235 units of service including I/R, consults and training.
- ✚ ASAGA Board and Volunteers provided 18 volunteer hours
- ✚ ASAGA connected with individuals in 18 Alaskan communities and Out of State guardians
- ✚ ASAGA hosted an advanced training in Palmer, Juneau, Fairbanks, and Soldotna titled Guardianship 101 about not what a guardian's authority was but how to ideally use it. Events were scheduled in Valdez and Anchorage that had to be cancelled due to the statewide lockdown for Covid-19. The April 10th Anchorage session will be via webinar to address those who were not able to attend. ASAGA held two standing webinars each month on Fundamentals of Guardianship and How to do the Annual Report.
- ✚ We had 3730 visits to our webpage with Education Resources being the top page after Welcome followed by Calendar of Events! Through Facebook, we have 360 followers and have reached over 2200 individuals with posts. We have 1661 subscribers to our e-distribution each month and 54 registered for the Annual Report Reminder
