OPENING SESSION

Sex, Drugs and Rock and Roll

Megan Brand Peter Wall

A panel discussion reviewing uncommon requests made to trustees, conservators, guardians and agents. Case Law, litigation avoidance, drafting tips, decision making tools and distribution structures will be discussed with perspective provided from three different professional fiduciaries and counsel.

Goals and Objectives: The attendee will have a better understanding of how and when to use the Financial Abuse Protection Orders (FAP) and their role in filing them.

Join in for this interactive discussion of the NGA Standards related to Self-Determination, the importance of keeping the individual a focus in all proceedings and real-life scenarios encountered by the presenter that challenge even the best decision makers.

Goals and Objectives: The attendee will gain perspective on how to make a person's self-determination a priority

LUNCH SESSION

Guardianship Around the World

Bob Fleischner

Bob Fleischner will present a brief history of guardianship from the Roman Empire to current times. He will survey the exciting changes in guardianship law and practice that many nations have enacted or are actively considering in response to Article 12 of the United Nations Convention on the Rights of People with Disabilities. Special attention will be paid to laws that encourage the use of supported decision-making as a means of ensuring dignity and enhancing personal decision-making. Finally, turning his attention to the United States, Bob will discuss the new model uniform guardianship law and how some states are responding to the growing interest in supported decision-making.

Breakout Sessions #2

Dignity of Risk and Guardianship

Bob Fleischner

This presentation will focus on the concept of dignity of risk, or the right to fail, and its implications for guardianship and other forms of substituted decision-making. Bob Fleischner will explore how, beginning in the 1970s, the idea that people learn through their experiences, even bad experiences, was applied to people with disabilities. He will consider the sometimes conflicting duties of providers and others, on the one hand, to protect the person and, on the other, to allow and even encourage the person to experience new things, even if there is a risk to doing so. Finally, using examples from his experience, he will discuss how the dignity of risk is essential to supported decision-making and how it is applied in real life.

Goals and Objectives: Attendees will have an understanding of how to better balance protection with the dignity and right to fail using history, experiences and new tools.

Sexuality and Risk Geno Daly

This session will focus on how to detect warning signs about problematic sexual behaviors. The presenter will include information about how to maneuver if you have an individual involved with the Department of Corrections, the State of Alaska Senior and Disability Services and the role of the Center for Psychosocial Development as a provider.

Goals and Objectives: Attendees will have a better understanding of resources if caring for or working with a person at high risk of problematic sexual behaviors while having their own beliefs challenged in a way that provides more perspectives.

Breakout Sessions #3

SDM Pilot Outcomes

Bob Fleischner and Anne Applegate

Panelists will discuss the outcomes of SDM pilot programs in the US and elsewhere. The independent evaluation of a project sponsored by the Center for Public Representation and Nonotuck Resource Associates will highlighted, including descriptions of the personal outcomes for the participants, their families and their supporters.

Goals and Objectives: Attendees will see how supported decision making has been implemented to have a better understanding of the SDMA concepts.

Trusts, Trusts, Trusts:

Megan Brand is the Executive Director of CFPD-Colorado Fund for People with Disabilities. Megan began her service at CFPD in 2003 and has been the Executive Director since 2010. Megan has a bachelor's degree in social work from the College of St. Benedict over 20 years of experience in working with people with disabilities, their families, service providers, attorneys, trustees, financial planners, guardians and other professionals. She leads a staff of 25 in administering the largest and longest-standing locally managed pooled trust in Colorado, as well as providing myriad of other services that offer protection, personalized attention, access to our network of organizations and services, and financial and benefit's guidance. In addition to leading the staff, Megan is a former board member of the Colorado Guardianship Association and currently serves on the board for the National Planned Lifetime Assistance Network and Community Living Alternatives and is a frequent presenter in the community, both locally and nationally, on Special Needs Trusts.

Peter Wall is the National Oversight Manager for BOK Financials Disability and Elder Trust Solutions division, and is a Vice President for Colorado State Bank and Trust. Now in his 18th year of trust administration, Peter focuses his efforts in the Elder Law arena and is known for his Special Needs Trust administration and planning capabilities throughout the country. Mr. Wall is the outgoing President for the Centennial Estate Planning Council, former President of the Denver Trust Officers Association, and President of VSA Colorado Access Gallery. He is a frequent presenter on the topics of Special Needs Trusts, estate planning, taxation, and trust administration for numerous professional and community groups and was a presenter and faculty member at the CBA 2012, 2014, 2015 & 2017 Elder Law Retreat, the 2013 National Down Syndrome Congress, the 2015 46th Annual Autism Society National Conference, the 2016 CBA Estate Planning Retreat, the 2016 Stetson National Special Needs Trust Conference and the 2017 National Conference for the National Guardianship Association. Mr. Wall is also a published author, most notably in the Elder Law in Colorado Red Book, Fourth Edition. Peter

MASSACHUSETTS

Bob Fleischner has been a disability rights attorney since 1973. He worked for more than 40 years at the Center for Public Representation, a national public interest law firm with offices in Northampton, Massachusetts and Washington, DC. A graduate of Boston College Law School, Bob is the former co-director of the Center's successful and innovative Supported Decision Making project. An experienced trial and appellate attorney, he has litigated cases and argued appeals involving guardianship, prison and juvenile justice reform, fair housing, civil commitment, right to treatment, and right to community services in state and federal courts around the country. Bob has served on the adjunct faculties of Western New England University Law School and Smith College School for Social Work. He has published a book on guardianship law and numerous articles and book chapters about disability law.

ALASKA

Beth Goldstein is the Supervising Attorney for the Office of Elder Fraud and Assistance (EFA) at the Office of Public Advocacy (OPA). EFA assists individuals 60 and over who have been defrauded or who have suffered financial exploitation. Prior to her current position, Ms. Goldstein served as the Deputy Director for OPA, as an appellate attorney for the agency and as a trial attorney for the agency. She has been with OPA in these various capacities since 2006. Prior to coming to Alaska, Ms. Goldstein served as patent counsel at the Procter & Gamble Company, Sr. Licensing Counsel at NCR Corporation and as an Assistant Federal Public Defender in the Southern District of Ohio. Ms. Goldstein graduated from the University of New Hampshire School of Law (formerly Franklin Pierce Law) and has been a practicing attorney for 25 years.

Anne Applegate graduated from UC Berkeley in 1989 with B.A. in Anthropology; and from UC Hastings College of the Law with a J.D. in 1994. She studied international law in Strasburg, Brussels, and Vienna. As a law student, Anne interned at Disability Rights Wisconsin and was a non-governmental organization delegate to the UN World Conference on Human Rights in Vienna. She was admitted to practice law in Wisconsin in 1994 and in Alaska in 2000. Anne has been a judicial clerk, a sole practitioner, an associate in a general practice firm, and a staff attorney for the designated Alaska Protection and Advocacy Agency, Disability Law Center of Alaska (DLC). Anne has taught Disability Law and Ethics at the University of Alaska Anchorage as an adjunct instructor and joined the staff of the Governor's Council on Disability and Special Education as a Program Coordinator II in March of 2017.

Geno Daly began his worked as a clinician at the Center for Psychosocial Development in June 2002 and has been the Director since 2005. Geno is a Licensed Clinical Social Worker, Chemical Dependency Counselor II, and a Sex Offender Treatment Provider. CPD provides specialized treatment for individuals who experience intellectual developmental disabilities, cooccurring mental health illnesses, trauma histories, substance abuse histories and high-risk sexual behaviors.

Karen Ward, Ed.D., is the Director of the University of Alaska Anchorage Center for Human Development, UCEDD. Dr. Ward has wide experience as an educator, practitioner, and researcher in the field of disabilities, with training, experience, and published research in

disability victimization and sexuality. She is the founder of the Friendships & Dating Program, that teaches social skills to individuals with intellectual and developmental disabilities to promote sexual health.

Julie Atkinson is a Research Professional at the University of Alaska Anchorage Center for Human Development. She is the program coordinator for the Friendships & Dating Program overseeing training, implementation, evaluation, and technical assistance. Julie holds a Master of Science from Utah State University and has worked as an aide in state government on health and disabilities issues.

Angela Gray, MS, CRC is a Vocational Rehabilitation Counselor for the Division of Vocational Rehabilitation and has been with the agency for 10 years. She received a M.S. in Rehabilitation Counseling from Virginia Commonwealth University and is a Certified Rehabilitation Counselor. She has over 15 years of experience working with individuals with disabilities and currently provides services to a general caseload, transitioning youth, and individuals who are deaf and hard of hearing.

Juan San Miguel was born in Guayama, Puerto Rico, raised in Bethlehem, Pennsylvania and currently resides in Anchorage, Alaska. He served in the United States Army from 7/78-9/92 and attained the rank of Sergeant First Class as a Food Service Specialist. Juan graduated from Central Texas College (Associate in General Studies), and Alaska Pacific University (Bachelor in Organizational Management). He has attended Leadership Anchorage as well as numerous leadership courses in the military. Juan currently owns Louisa's Legacy providing Care Private Guardianship, Conservator, and Trustee services to vulnerable adults and the elderly in Alaska. Juan takes pride in helping people in his community. He serves as Immediate Past President of Alaska PTA and is on the ASAGA Board of Directors. Juan is married to Teresa for 34 years with three daughters, Teresa Marie, Cassie and Kristine. He also has two grandsons Dakota and Christian.

Patrice A. Icardi is an elder law attorney in Anchorage, Alaska. She is a Pennsylvania native and a graduate of Florida State University (1977 B.A. American Studies), Duquesne University School of Law (1981 Juris Doctor) and Stetson University College of Law (2010 Masters of Law in Elder Law (LL.M.) Ms. Icardi is a member of the Alaska Bar Association and the Florida and Pennsylvania Bars but practices exclusively in Alaska. She is a member of the National Academy of Elder Law Attorneys (NAELA) where she currently serves on the Guardianship and Conservatorship Steering Committee. She is also a member of Elder Counsel and serves on the Board of ASAGA. Her practice areas include the issues and concerns of the elderly and disabled populations, Medicaid planning, probate, Special needs trusts and guardianship and conservatorships.

Lisa Wawrzonek, MS has been a Court Visitor investigating adult guardian and conservatorships for over 18 years. She graduated from UAA with a Bachelor's in Human Service, an Advanced Human Service Certificate and a Masters in Gerontology. She sent 15 years with the Alzheimer's Resource of Alaska as a care coordinator, supervisor and Education Director. She is a past board member of ASAGA and is currently the administrator of ASAGA.
